CONSIDER AND TAKE ACTION WITH RESPECT TO A RESOLUTION AUTHORIZING THE CALLING AND HOLDING OF AN ELECTION IN THE CITY OF HARRAH, STATE OF OKLAHOMA (THE "CITY"), FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED QUALIFIED ELECTORS OF SAID CITY THE QUESTION OF APPROVAL OR REJECTION OF AN ORDINANCE OF THE CITY, WHICH AMENDS THE HARRAH CODE OF ORDINANCES (I) BY ELIMINATING THE STATED TERMINATION OF A ONE PERCENT (1%) EXCISE TAX (SALES TAX) CURRENTLY SCHEDULED TO TERMINATE JUNE 30, 2021 AND (II) BY ELIMINATING THE STATED TERMINATION OF A ONE PERCENT (1%) EXCISE TAX (SALES TAX) CURRENTLY SCHEDULED TO TERMINATE SEPTEMBER 30, 2028; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

CONSIDER AND TAKE ACTION WITH RESPECT TO AN ORDINANCE OF THE CITY OF HARRAH, OKLAHOMA (THE "CITY"), AMENDING THE HARRAH CODE OF ORDINANCES (I) BY ELIMINATING THE STATED TERMINATION OF A ONE PERCENT (1%) EXCISE TAX (SALES TAX) CURRENTLY SCHEDULED TO TERMINATE JUNE 30, 2021 AND (II) BY ELIMINATING THE STATED TERMINATION OF A ONE PERCENT (1%) EXCISE TAX (SALES TAX) CURRENTLY SCHEDULED TO TERMINATE SEPTEMBER 30, 2028; PROVIDING FOR THE EFFECTIVE DATE; PROVIDING REMAINDER OF ORDINANCE REMAIN UNCHANGED; PROVIDING THAT THE PROVISIONS OF THIS ORDINANCE ARE CUMULATIVE AND IN ADDITION TO ANY AND ALL TAXING PROVISIONS OF OTHER CITY ORDINANCES OR THE CODE OF ORDINANCES; PROVIDING FOR SEVERABILITY OF PROVISIONS; AND CONTAINING OTHER PROVISIONS RELATED THERETO.
