a. Discussion and possible action to review and study dispersing ARPA funds.

The Council and Trustees reviewed the request from each department on what their priorities would be for the ARPA money. The departments each gave a list for review and discussed the priority needs as they went over each item with the council and trustee. The mayor/chairman requested a special meeting for Thursday, March 9, 2023 to go more in depth on which items could go on the next budget or look for grants for some of the items.

b. Discussion and possible action to allow the Park Board to enter into an updated contract with Mountain Smoke for \$2000 for a concert in the park (April 22,

c. Discussion and possible action on a new concessionaire for the Heritage Park Concession Stand. (<u>Proposal</u>)

Mr. Tony's submitted a proposal to the council to take over the concession at Heritage Park. The mayor and two council members visited the concession stand on separate occasions to see the condition of the concession stand and they were all disappointed in the condition that the concession stand was left in. The mayor proposed that Mr. Tony's pays \$1 a month for a year plus gas and electric while the extensive clean-up was going on. The city would replace 3 windows, the counter tops on the inside and outside. Mr. Tony's would take care of the fire suppressant system and inspection.

Motion by Rudek to approve the city attorney bring a new contract to the next meeting with the stipulations addressed for the city and Mr. Tony's for one year. Second by Klimkowski. Motion carried.
