 - a. Public Hearing on the 2025-2026 Fiscal Year Budget.

Public hearing was opened at 6:56 pm, Hans Willemse from the Harrah Historical Society spoke about adding a fund for the Harrah Historical Society to the budget for the 2025-2026 Fiscal Year, as had been discussed in June of 2024. Michele gave some background information on the funds the City provided to the Harrah Historical Society in 2024 and the process to request funds for future budget years. Public hearing was closed at 6:58 pm.

Scalzo asked for update on easements, asked Chief Burns about guy living on side of the road compared to guy living in house damaged by tornado and why one could be removed and the other hasn't been, and about status of getting rid of roosters behind Rocky's property and code enforcement enforcing high grass and weeds.

Rudek asked about the sod in the park and the size restrictions to have 6 chickens, wanted the record to show that he has concerns about how the City Manager handled the easements.

Lisby said the OML training was informative.

McCammond said the budget process was a learning experience.

Community Comments:

Jeff Brzozowski informed Council there was no silt fence at the project along Harrah Road along the White Turkey Creek and the silt is damaging his property, he wants the City Manager to push the contractor to install silt fence. The sewer project is majorly impacting his produce business and he is concerned about the impact on other businesses along its path. He suggested the contractors work nights and weekends to finish the project quickly. He mentioned that our fireworks ordinance does not match the state regulations. He wants a franchise fee update, City Clerk stated she would send him one. He mentioned that funding for the Historical Society for the 2025-2026 budget was voted on at the June 10th, 2024 meeting.

Cathey Byerley gave an update about the Hello Summer event this weekend and informed Council that the parking lot would be closed for the inflatables.
