Returned to open session at 7:50 pm.

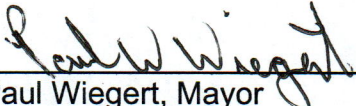
A motion was made by Rudek and seconded by McCammond to allow the City Manager to proceed with discussion to obtain land and easements as discussed in Executive Session.
