- c. Discussion and possible action to adopt Ordinance No. 2025-18 rezoning property at 1260 S Harrah Rd from R1A, R2A and C1 to PUD (Staff Report)

David Box spoke as the applicant in favor of the rezone. Jeff Brzozowski, Don Zawisza and David Zawisza spoke with concerns against the rezone, citing concerns with drainage, traffic, impact on schools, and impacts on their property.

A motion was made by Scalzo and seconded by McCommond to adopt Ordinance No 2025-18 with modifications and additions to the Master Design Statement to include Section 9.8, the addition of drive-thru speaker boxes shall be located 50 feet away from the residential district, Section 9.9 the addition that the maintenance of all common areas will be the responsibility of the Homeowners Association and that there will be a minimum of two ADA-compliant amenities included, which could be a playground, basketball court, pickleball court or walking trails, Section 9.10 the addition of providing for an 8 foot high wall or fence on the north side by the industrial park and a 6 foot high fence along the east boundary, subject to not interfering with drainage, Section 9.13 the addition to require street lights with decorative poles installed at all internal street intersections with mid-block lights with decorative poles to be installed along each block with a length in excess of 600 feet and stop signs and street signs will also be the decorative style and finally an addition to Section 9.1 to prohibit the use of brick panels on the facade.

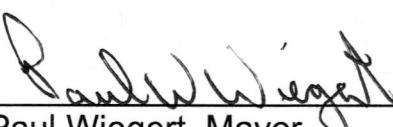
