**Food Truck Park Rules and Policies:** Please read and confirm agreement with each Policy:

### **Rain & Weather Policy**

- The food truck park operates rain or shine unless conditions are deemed unsafe by management.
- Unsafe conditions may include severe storms, high winds, flooding, lightning, or other hazards.
- If management closes the park due to weather, vendors will be offered a reschedule date or credit toward a future booking.
- If the park remains open and a vendor chooses not to operate, standard cancellation policies apply.
- No cash refunds will be issued for weather-related closures; credits will be applied instead.

I have read, understand, and agree to comply with the Rain and Weather Policy.

### **Operating Rules & Safety Compliance**

- Vendors must operate only during their approved reservation time.

- Vendors must arrive, set up, and vacate their space within their assigned time slot.
- All trucks must comply with local fire, health, and safety regulations at all times.
- Fire extinguishers must be onboard and easily accessible.
- Open flames, grills, fryers, and smokers must be monitored at all times while in use.
- Generators must be properly maintained and operated in a manner that minimizes noise, fumes and safety risks.
- No dumping of grease, wastewater, or food waste on park property. All waste must be removed by the vendor unless designated disposal is provided.
- Vendors are responsible for keeping their assigned area clean and free of debris.

**Indemnification & Liability Acknowledgement**

- Vendors operate at their own risk while on park property.
- The food truck park, its owners, staff and affiliates are not responsible for loss, theft, or damage to vendor property.
- Vendors agree to indemnify and hold harmless the food truck park from any claims, damages, injuries, or liabilities arising from their operations, employees, contractors, or customers.
- Vendors are responsible for maintaining valid liability insurance as requires by local regulations.

**Cancellation Policy**

- Cancellations must be made at least 3 business days prior to the scheduled reservation to avoid forfeiture of payment.
- Cancellations made within the cancellation window are non-refundable.
- Failure to show up without notice will result in forfeiture of payment and may affect future booking eligibility.
- Management reserves the right to waive cancellation penalties at its discretion in exceptional circumstances.

**No Exclusive Menu Policy**

- The food truck park does not guarantee exclusivity for any cuisine, menu item, or food type.
- Multiple vendors offering similar or overlapping menu items may operate concurrently.
- Vendors acknowledge that competition is part of operating within a shared food truck environment.

**Additional Policies**

- Noise policy:
- Music and generator noise must remain at a reasonable level and may not disturb neighboring vendors or surrounding properties
- Signage & Advertising:
- Signage must remain within the vendor's assigned space and may not obstruct walkways or neighboring trucks.
- Alcohol Sales:
- Vendors may not sell or serve alcohol unless part of a City authorized Special Event with a Special Event ABLE Permit and all required licenses.
- Code of Conduct:
- Vendors and staff must conduct themselves professionally and respectfully toward customers, other vendors, and park staff.
- Harassment, unsafe behavior, or noncompliance may result in immediate removal from the park.
- Right to Refuse or Terminate:
- Management reserves the right to refuse service, deny future bookings, or terminate a vendor's operation for violations of park rules or policies.
